

MUST BE RECEIVED BY 19th WITH THE MONIES

- This is a legal requirement and we now have to report failures to the Pension Regulator! who will fine LBH.
- **Do Not** manipulate the cells or the spreadsheet at all.
- If there is a leaver or starter on the HK221 we should have had the relevant form.
- Levies will be raised for missing info/forms/late payments and for data submitted on incorrect HK221s



Year End Data - Do You Remember This!!!

Valuation Year - Data to actuary by 24/06/2016

Data must be returned by 15/04/2016 – no exceptions!!

Equiniti to send queries by 30/04/2016

Responses to queries by 06/05/2016 – no exceptions!!

One line per job is vital

Data was incorrect e.g no fte's



THE OUTCOME OF NON RECEIPT AND INCORRECT DATA.

- Valuation data EQ submitted to Hymans was late
- Valuation data was incorrect
- Benefit Statements couldn't be issued by August so
- Pension Regulator had to be informed he will impose fines next year that will be paid by London Borough of Hackney.
- £56,000 additional work to produce the statements/valuation data
